- The built-up Raw / Bare shell space will be rented to the IT/ITES/ESDM preferably STPI registered companies initially for a period of 5 Years, which can be extended on mutual consent & agreed rentals.

- 3. Electricity charges will be paid by the company as per the actual. For HVAC, charges will be 0.7 unit/sq ft/month payable by the company.

- 4. Rentals: Rs 58.00/- Sq.ft/month (for 12 hrs operation) and Rs. 65.00/Sq.ft/month (for 24 hrs operation). The Rates mentioned are including common area maintenance (CAM) charges and excluding GST & other applicable taxes.
- 5. Rental Increment on Final Rate will be 5% on a compounded basis from 2nd year onwards, at the time of auto renewal of each year during the initial period of 5 years.
- 6. The successful company will be selected based on an evaluation process by the Advisory Board.
