With reference to the letter cited above, the following information is furnished for your information and further necessary action:

- In continuation to this office letter dated 10.01.2019, it is to inform that new OSP guidelines have been received vide letter dated 06.09.2020, which is attached for your reference please. According to the new guidelines the companies are not required to register as OSP anymore.
- 2. During the recent initiative taken by this office for arresting the illegal grey call setups, it has come to light that many of the companies are using the services of foreign / illegal service providers like Vonage, Vaotech, Vitelity, A Lingo Inc, SRV Techno Solutions, Ring Centrl etc, The Usage of telecom resources of foreign and un-licensed service providers in India is illegal and it is requested to bring it to the notice of all the companies registered with STPI. The updated list of licensed service providers providing the VoIP minutes in Hyderabad, as per the records of this office is annexed herewith for ready reference. However, the complete list of licensed ISPs can be obtained from the website www.dot.gov.in.

It is once again requested to bring the contents of this letter to the notice of all the companies registered with STPI, if required and also, to avail the services for their business needs only from the licensed service providers.
