Message from ARVIND KUMAR Director General, STPI

This techade is going to be a transformation phase for Indian agriculture, which was earlier plagued by heavy rainfall, reduction of groundwater level and insufficient vegetation cover among others. The government's distinctive focus on the digitalization of farming has boosted farm incomes and opened up newer avenues of opportunities for rural youth and farm workers. According to the STPI's AgriTech report, Innovations through Agritech, the agricultural export between April 2022-January 2023 stood at USD 43 billion. Investments in AgriTech startups grew at a CAGR of around 51 percent from CY 2017-2022. Emerging AgriTechs are solving critical problems like farm inputs, finances, labour shortages among others.

In the era of the Internet of Things (IoT) and AI revolution in

This futuristic initiative aimed at transforming the agriculture industry in India and enhancing farmers' livelihoods.

Agriculture, seamless integration of the technologies in agriculture is making farming 'smart' like our handsets and televisions. Farmers can monitor everything right from soil condition to greenhouse humidity levels in one go through these Sensors and Transmitters installed on IoT devices. On top of that, the data generated by these technologies is further assisting the industry in improving crop growing conditions and overall efficiency. The public-private partnerships (PPP) are leveraging the benefits of emerging technologies as the private sector is also introducing cutting-edge innovation in the areas of digitization and AI.

Modern agricultural technology increases employment, and efficiency in the production of food, saving time and reduction in costs. Farmers have gained significant With technology intervention at the forefront, the solutions developed through the SFGC challenge program will provide farmers with cutting-edge technologies and data-driven insights to optimize operations and boost harvest yields of sugarcane, which is an important commodity for human consumption as well as trade. The selected startups at various stages are being supported by MeitY, MeitY Startup Hub (MSH), STPI, Neuron CoE, DCM Shriram Sugar Mills & Directorate of Sugar Mills, in addition to the various mentors and industry experts. The challenge aims to predict the optimum time for harvest, estimate sugar content, identify mature plots, and provide insights in an easily interpretable format.

Building sustainable infrastructure for Electric Vehicle Charging station and mobility in India

EV Urjaa is an Indore-based automotive firm with a vision of building a hassle-free battery swap ecosystem for electric vehicles with long charging capability and low maintenance. Founded in 2017 by Shri Sanyog Tiwari, the startup is building an ecosystem for electric three-wheelers and two-wheelers across the Nation.

The company empowers local shop owners to become energy operators and boosts their income with the help of cutting-edge technology services including IT infrastructure, IoT-enabled batteries and fast-income charging stations.

Fast-income charging stations are fully smart machines that enable a quick battery exchange platform, which enables instant 2-minute swapping and saves the working hours of the riders. Nucleus (IoT device) enabled batteries are packed with facilities to mobilize & immobilize, theft protection, live tracking, battery health status monitoring, strong communication model, and in-built antenna.

EV Urjaa is also one of the proud winners of STPI's CHUNAUTI Challenge under NGIS (Next Generation Incubation Scheme). The company bagged a seed fund of Rs 25 lakh besides availing various services of STPI including physical incentives and soft support.

STPI, MeitY awarded ₹ 20 Lakh grant to 4 AgriTech Startups for creating solutions in growth of sugarcane harvest

STPI awarded the 4 winning AgriTech Startups with Product Development Grants of Rs. 20 Lakhs each for qualifying the second stage of the Smart Farm Grant Challenge (SFGC) Program on 31st January, 2023 . The award ceremony was held at Electronics Niketan, Ministry of Electronics and IT (MeitY) in New Delhi and saw the presence of Shri Alkesh Kumar Sharma, Secretary, MeitY, Gol; Shri Bhuvnesh Kumar, Additional Secretary, MeitY, Gol; Shri Akash Tripathi, Joint Secretary, MeitY, Gol and Shri Arvind Kumar, Director General, STPI; Dr Devesh Tyagi, Senior Director, STPI; Shri Saurabh Srivastava, Chairman, Indian Angel Network; Shri Roshan Lal Tamak, Executive Director of DCM Sriram, and other senior representatives from Ministry, STPI & Industry also attended the event.

SFGC was initiated with the goal of creating cutting-edge approaches for sugarcane harvesting and received an impressive response in the form of 474 submissions. The challenge aimed to predict the optimum time for harvest, estimate sugar content, identify mature plots, and provide insights in an easily interpretable format.

"With the products of these startups, we are hoping that it will increase the efficacy of the produce and ensure that the right kind of moisture is present in the soil. It's a matter of great pride that now academia is participating in creating a whole new ecosystem of end-to-end solutions," he said.

Sh. Arvind Kumar, DG, STPI said, "The challenge aims to provide a digital solution for optimum sugarcane harvest. The SFGC program was launched on 9th May 2022 to nurture the tech ecosystem from the newer cities. Today's felicitation is a testimony to the fact that two of the four selected teams come from Tier II/III cities of India ."

Amongst the 4 winners - AGAutomate Private Limited, GB Pant University of Agriculture & University, AGMitra Technologies Private Limited and Satyukt Analytics Private Limited - each will develop product over next 6 months and eventually one of them will be declared as final winner. The final winner will receive Rs 50 Lakh in the first year and Rs 10 lakhs per year for the next two years towards the operation and maintenance of the solution.

The expert Jury had pre-screened 108 applications and shortlisted 25 startups for pitch presentation. Subsequently, 10 startups were recommended for a prototype grant of Rs. 5 Lakh each in September 2022. After 3 months of rapid development and validation, the top 4 startups have been selected by the Jury for product development grant of Rs. 20 Lakhs each.

Speaking on the occasion, Sh. Alkesh Kumar Sharma, Secretary, MeitY, Gol, said when it comes to agriculture, a farmer is the most difficult entity. They live with the uncertainty of weather.

The winning solution will be deployed in 100-acre plot area for use by the government of India, State Government entities, and sugar mills for a period of three years. The winner startup will provide dissemination advisory to farmers for the next two years.

With programs like SFGC, MeitY and STPI are ushering a new course for innovation and entrepreneurship in the country that does not limit itself to Tier-I / Metro locations.

Govt. of India approves setting up of **Electronics Manufacturing Cluster** at Hubballi-Dharwad in Karnataka

The Government of India has approved setting up of the Rs 180 crore Electronics Manufacturing Cluster (EMC) at Dharwad on 24th March 2023.

The project, will come up in Kotur-Belur Industrial Area in the Dharwad District of Karnataka under the EMC 2.0 scheme, is expected to catalyse investments to the tune of over ₹ 1,500 crore soon. Nine companies, including startups, have already committed to making investments of ₹ 340 crores with an employment potential of 2,500 people.

This EMC has a strategic locational advantage and is well connected with NH-48 (1 Km), and Hubli Domestic Airport (33 Km), it will reduce the logistics/ transportationcosts to the Industries in the EMC.

The Centre has already approved a Common Facility Centre (CFC) for the development of an advanced testing facility in Mysuru, Karnataka that will meet the various testing requirement of the industry.

The Modified Electronics Manufacturing Cluster (EMC 2.0) scheme was introduced on 1st April 2020 to create world-class infrastructure along with the common testing facilities, including Ready Built Factory sheds/Plug & Play infrastructure for attracting Anchor units along with their supply chain to set up their manufacturing/production facility in the country.
