3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Buyer Added Bid Specific ATC

- 1. Within the scope of this contract the service provider shall provide vehicle services on Government Holi days, if required by STPI Gandhinagar at no extra cost.
