Terms and conditions:

A) GENERAL TERMS

- 1) The tender documents shall be treated as "confidential"
- 2) Each page of the tender document should be signed and stamped by authorized signatory.
- 3) Alterations, if any, in the quotation should be attested by the tenderer, failing which the tender is liable to be rejected.

D) INSPECTION, TESTING, ACCEPTANCE OF GOODS

All equipment upon delivery is subjected to inspection and testing for compliance of the specification of the tender. If faulty items found during inspection/testing, same has to be replace with new items immediately, otherwise payment will not be made. Wherever necessary, the vendor will be required to render suitable support for testing.
