- 1. - 2. The tender details are available at https://eprocure.gov.in/eprocure/app & http://www.kolkata.stpi.in.
- **3.** Each page of this tender document and all required documents must be signed, stamped & uploaded by ensuring the compliance with the scope & services and general terms and conditions. No overwriting, corrections and cutting is permitted.
- **4.** In case the day of opening of bids is declared as holiday, the opening shall be held on the next working day at the same time.
- 5. CONDITIONAL BID AND SPLIT WORK WILL NOT BE ACCEPTED AND REJECTED OUTRIGHT. THE SELECTED BIDDER MUST CARRYOUT THE WORK FOR ALL CENTRES AS MENTIONED.
- **6.** If any of the conditions of this tender is not fulfilled, such Bid/ Bids will be summarily rejected outright and objections raised in this regards will not be entertained.
- **7.** STPI may extend the last date of submission of bids or opening date as it deem required for any administrative reasons.



- **9.** Bids once submitted shall not allow being withdrawn. Any default after acceptance of bid shall be deemed to be noncompliance to the terms of contract. In that case, the submitted EMD may be forfeited.
- **10.** If the Bidder fails to provide services within the time period specified in the contract or any extension thereof granted by the STPI Kolkata, the submitted EMD of the successful bidder may be forfeited.
- 11. If the Bidder fails to remit the required amount and clear off the items within the specified time given by STPI Kolkata will have the power to cancel the offer and forfeit the EMD.
- 12. The bidder has to be registered with State Pollution Control Board/ Pollution Control Committee/ Central Pollution Control Board (CPCB) as per the E-waste (Management) Rules 2016 published by the Ministry of Environment and Forest, Govt. of India. The bidder must upload the copy of registration certificate from respective pollution control board.





- 13. The bidder must submit an undertaking as per Annexure-C & D (with company stamp and signature) that the facility & recycling process are in accordance with the standards laid down in the guidelines published by the CPCB from time to time.
- 14. The bidder should submit an undertaking as per Annexure that the residue generated thereof is disposed of in a hazardous waste treatment storage disposal facility.
- 15. The buyer should clear off all the items at their own cost within 04 weeks from the receipt of sale letter on production of their identity proof and original cash receipts for the amount remitted with the sanction of the concerned authorities in the presence and supervision of respective committee. STPI-Kolkata will not be held any responsibility for any loss or damages or theft of the material after the bid is finalized and sale letter issued to the buyer, and no compensation thereof, will
- 16. The successful bidder will be allowed a maximum period of 07 days after receipt of the confirmation letter to remit quoted amount. The lifting of scrap will not be allowed before the submission of quoted amount in form of NEFT. The copy of the NEFT payment along with the UTR number must be submitted at this office. The amount of duties and taxes if any, shall be charged extra.

#### 20. Award Criteria

Contract will be awarded on the basis of **Highest total of Financial Bid (H1) as per the BOQ in Annexure - E. The Basic rate in BOQ must be matched with the Grand Total Amount of Items wise rate of Annexure - F of the acceptable responsive bidder who complies with all terms and conditions of the tender. In case the <b>H1** vendor is not able to accept the sale letter within 07 days, the same will be offered to next lower bidder (H2) at rate given by H1. STPI reserve the right to split the order on highest rate/s of respective items basis.

#### 21. Payment Terms

Successful bidder have to submit the quoted amount (including all taxes) in the form of NEFT, as per the account details given in **page no.:03**, **point no.:11** within 07 days. The copy of NEFT must be sent/ submit at this office as proof of payment before lifting/ loading the listed items from any center/s.

#### 22. Termination by default:

- a) STPI reserves the right to cancel the Work Order at its discretion at any stage/ time without assigning any reason, thereof.
- b) The STPI Kolkata may, without prejudice to any other remedy for breach of contract, by written notice of default sent to bidder, terminate the Contract in whole or part.
- c) If the Bidder fails to provide services within the time period specified in the contract or any extension thereof granted by the STPI Kolkata.
- d) If the Bidder fails to perform any other obligations under the Contract.
- e) If the Bidder transfer/sub contract the works under any obligation.
- f) The selected bidder must not execute the work order through any THIRD PARTY Agency.

#### 23. Rejection of the bid

- a) The bidder is expected to examine all instructions, formats, terms & conditions, & scope of work in the bid document. Failure to furnish all information required as per bid document or submission of bid which is not substantially responsive to the bid document in every respect may result in rejection of bid. In respect of interpretation/clarification of this bid document and in respect of any matter relating to this bid document, the decision of STPI-Kolkata will be final.
- b) In case the selected bidder does not show interest in lifting the goods, the submitted EMD will be forfeited.
- c) The bidder will have to furnish the requisite document as specified in the bid document, failing which the bid is liable to be rejected.
- d) The bid/s must be uploaded Online Mode through CPPP Portal only. Any other mode will not be considered. STPI Kolkata will not entertain anything in this regards.

#### 24. Blacklisting

Company/ Firm blacklisted by Govt./PSU/Corporate organization as on the date of closing of bid are not eligible to Bid [Declaration for the same must be furnished as per **Annexure-B** (with company stamp and signature)]. If at any stage of bidding process or during the currency of contract, such information comes to knowledge of STPI - Kolkata, the STPI shall have right to reject the bid or terminate the contract, as the case may be, without any compensation to the bidder.



#### 25. Arbitration

All disputes or difference whatsoever arising between the parties out of or relating to the meaning and operation or effect of the purchase order/work order or the breach thereof shall be settled by reference to arbitration as per Indian Arbitration Act. In such case, the same shall be referred to the sole arbitration of Director, STPI- Kolkata.

#### 26. Force Majeure

If, at any time, during the continuance of the agreement, the performance in whole or in any part by either party of obligation under the agreement shall be prevented or delayed by reasons of any war, hostile acts of the enemy, civil commotion, subrogate, fire, floods, earthquakes, explosions, epidemics, strikes and quarantine restrictions by acts of God, (herein after referred to as eventualities) then provided notice of the happening of any such eventualities is given by either party to the other within two days from the date of occurrence thereon, neither party shall, by reason of such eventualities be entitled to terminate this contract agreement nor shall either party have any claim of damages against the other in respect of such non performance or delay in performance. Performance of the contract agreement shall, however be resumed as soon as practicable after such eventuality has come to an end.






