3 Overview

Software Technology Parks of India was established and registered as an Autonomous Society under the Societies Registration Act 1860, under the Ministry of Electronics and Information Technology, (the then Department of Electronics), Government of India on 5th June 1991 with an objective to promote Software export from the country, set-up and manage infrastructure facilities and provide other services like technology assessment and professional training. The first historic event that triggered the high-octane growth of IT Industry in India was the establishment of three Software Technology Parks (STPs) at Bengaluru, Bhubaneswar and Pune in 1989. Consequently, in 1991 these three STPs were merged to create a single entity Software Technology Parks of India.

Since its inception in 1991, STPI has been working towards equitable and inclusive IT-led growth pan-India which in turn has helped promoting Software exports, Science, Technology & Innovation (STI) and Software product development. With 14 jurisdictional directorates and 65 centres, STPI has expanded its presence pan-India to support IT/ITeS Industry. Working closely with all stakeholders, STPI has played a key role in transforming the country as the preferred IT destination.

STPI is aspiring to become the largest technology startup ecosystem in the country and has been endeavouring to transform the country into a software product nation as envisaged in National Policy on Software Products (NPSP) 2019. In order to achieve this, STPI has evolved a collaborative model wherein government, industry, academia, and other stakeholders are playing a vital role in providing end-to-end support to startups. Aligned with this vision for promoting R&D, innovation, product & IPR creation, STPI is providing state-of-the-art infrastructure, skilling, mentoring, market connect and other necessary support pan-India to startups.

STPI has been actively working towards strengthening the start-up ecosystem by implementing various policies and initiatives, as well as establishing enabling networks. For building India's leadership in various technology domains, STPI has established 24 CoEs (Center of Entrepreneurship) across the country in a collaborative manner. A CoE is a domain-specific specialized incubation facility for start-ups in the area of emerging technologies where the higheststandards and best-practices in terms of infrastructure, technology, leadership, mentoring, training, research & development, funding, networking for the given focus area is made available. STPI CoEs are building innovation driven emerging tech-startups ecosystem in collaborative manner pan India. Another important initiative of STPI is Next Generation Incubation Scheme or "NGIS" which is a futuristic & comprehensive incubation scheme entrusted by MeitY to STPI covering 12 locations across the country. With the extensive presence and a robust network of partners and mentors, pan-India incubator/accelerator, STPI has become one of the largest successfully nurtured/supported over 1200 start-ups to date.



3.1 STPI Guwahati Directorate

STPI-Guwahati is one of the 14 STPI Directorates and having its administrative jurisdiction across 8 States of North East India. STPI-Guwahati centre was established in 2000 to fulfil the objective of organisation like implementing STP/EHTP Schemes, setting up & managing infrastructure facilities, and providing other services like technology assessment and project management consultancy in North East Region. 3.2 STPI Start-up initiatives in the North East Region

Out of the 24 CoEs established by STPI, 08 internetworked CoEs + Start-up Innovation Zone (SIZs) are established in 8 State Capitals of the 8 North East States, collectively called as OctaNE. OctaNE scheme is majorly funded by Ministry of Electronics and Information Technology (MeitY) and being implemented by STPI Guwahati to support technology led innovation in the region. Each CoE under OctaNE is self-sufficient in its domain but together all CoEs provide bouquet of services to the start-ups in emerging technologies. OctaNE CoEs are focusing on the various emerging technologies in AR/VR at Imphal, Healthcare & AgriTech at Gangtok, GIS Applications including Drone Technology at Itanagar, IT Applications in Graphic Design at Kohima, Gaming and Entertainment at Aizawl, Data Analytics & AI at Agartala. The OctaNE CoE for "IoT in Agriculture" has been established at STPI-Guwahati.

3.3 STPI OctaNE Centre of Entrepreneurship (CoE)

In August 2018, Hon'ble Minister of Electronics & Information Technology, Govt. of India launched the vision document for Digital North East 2022. The Vision Document provided a roadmap for translating the vision of Digital North East 2022 into firm action plan for each of the North East State.



As per the objective laid down in the vision document for Digital North East 2022, STPI was assigned with the responsibility to setup Centre of Excellence/Entrepreneurship & Start-up Innovation Zone in each of the state of North East India.

To fulfil these visions into reality, STPI under the support of MeitY has put continuous effort, in setting up of OctaNE – Internetworked North East Centres of Entrepreneurship to support technology led innovation. OctaNE is an umbrella of 08 nos. of CoE+SIZ in Northeast region, each CoE+SIZ under OctaNE will be self-sufficient in its domain but together all CoE+SIZ will provide bouquet of services to the start-ups in emerging technologies.

Focus Areas of the OctaNE Centres of Entrepreneurship (CoE)

Centre of Entrepreneurship has been envisaged as a facility to be utilised by start-up companies having clear idea of their product and having a business plan (including in the E-Commerce facilitation). On the other hand, start-up Innovation zone has been projected as a facility for tinkering based innovation by students and youth, some of whom are expected to become a start-up.

Component and benefits under of STPI OctaNE CoEs are,

- 1. Plug & Play (P&P) incubation facility
- 2. Domain specific Lab
- 3. Startups Innovation Zone (SIZ)
- 4. Direct funding support to startups up to INR 25 Lakhs
- 5. Mentoring support
- 6. Marketing support
- 7. Access to funding
- 8. IPR Support services etc.

All the above mentioned CoEs have been established except that of Itanagar where the Lab equipment is under procurement.



3.4 OctaNE CoE Startup Innovation Zone (SIZ) along with E-Commerce facilitation Centre

The main objective of such 'Innovation Zone' is to develop a tinkering and innovation culture amongst students and professionals. In fact, the innovation zone will be available to interested students and professionals to work creatively with emerging technologies, which is expected to result in the development of innovative Startups. This is expected to strengthen the culture of digital innovation in the NE states. The success criteria of the 'Innovation Zones' will be based on the number of students and professionals using the tinkering facility as well as the output of tinkering activities in concrete terms.

The concept of 'innovation zone' has its genesis in the tinkering activities encouraged in the innovative institutions across the world, which have contributed to the rapid growth of the Startup culture. In fact, the success of the startup movement depends upon the work being done earlier to promote such innovative out of box activities amongst young persons from the college level onwards.

Considering the North East states of India, the success of these states (as well as the rest of the country) rests on the ability of the organizations to harness the creative potential of the youth in positive directions to develop innovative ideas. Since the innovation zones will act as hubs to promote creativity amongst the youth and inspire them to work forward to start-up business in the future in IT and electronics.

The proposed 'innovation zone' will be aimed at students in nearby institutions and other youth to tinker with equipment and ideas to promote the culture of innovation and start-ups (including in E-Commerce). The zones will provide support like mentorship and limited funding support to foster innovative approaches. The hubs will network with similar facilities located elsewhere, in order to accelerate the benefits of tinkering-based innovation. In addition, the youth and students will be assisted to participate in innovation events held in the country.

Under the E-Commerce facilitation, support will be extended to Startups through mentorship and other services in the following areas-

- Choosing a Product
- Research and Preparation
- Setting-up the E-Commerce Business
- Preparing to Launch
- Post Launch support such as acquiring customer & marketing.

The budget estimate for setting up OctaNE CoE Startup Innovation Zone (SIZ) along with E-Commerce facilitation Centre at Guwahati is Rs. 30 Lakhs.



4 Purpose of EOI

STPI Guwahati invites Expression of Interest from the Indian registered company interested & having capability to undertake the establishment of a Startup Innovation Zone on IoT technologies including their usage in Agriculture & allied sector on turnkey basis for establishment of a **Startups Innovation Zone (SIZ)** along with **E-Commerce facilitation Centre** at the existing *"Internet of Things (IoT) in Agriculture* Centre of Entrepreneurship (CoE)" in the premises of STPI-Guwahati.

The agency should have relevant experience in Setting up of (Designing Layout, Supply of Equipment, Installation and Training) Start-up Innovation Zone (SIZ)/IoT Labs/Tinkering labs/Smart Labs/Fab labs/ Smart IoT solutions etc in Emerging Technologies and should have experience of providing technical support and services in Emerging Technologies. The agency is expected to establish **Start-up Innovation Zone (SIZ) along with E-commerce facilitation centre at STPI CoE Guwahati** on IoT technologies including their usage in Agriculture & allied sector **on turnkey basis.** The tasks include engineering & design, supply, site preparation, installation and commissioning of equipment/display models, tests & trials, training etc.

The companies/agencies shortlisted through this EoI will be issued Request for Proposal (RFP) document for submission of bids and final selection.



5 Scope of Work

- STPI requires to set up the Start-up Innovation Zone (SIZ) along with E-commerce facilitation centre in Emerging Technologies facility at Centre of Entrepreneurship (CoE) Guwahati.
- STPI requires setting up SIZ facility to encourage the development of a tinkering culture amongst students and professionals, who will be targeted by awareness campaigns about the facilities. This will create a culture of digital innovation in the region.
- It is envisaged and expected that the agency would establish (design layout, supply equipment, installation and impart training) SIZ facilities at STPI-Guwahati under OctaNE CoEs (IoT in Agriculture & Allied Sector) on turnkey basis. The SIZ should typically be able to display IoT Based Technology solutions for fast and better efficiency.
- It is expected that the agencies shall thoroughly assess the latest industry standard and specification while proposing the equipment for IoT in Agriculture & Allied Sector.
- Interested agencies are advised to visit the CoE facility at STPI-Guwahati for a better understanding of the layout before submitting their bid against this EoI.

A layout diagram of the SIZ area at STPI-Guwahati CoE along with some indicative basic concept are given below for reference of prospective agencies. It may be noted that the physical area as shown in below SIZ area is ready, however the equipment shown are not present and just part of a concept only.

The total SIZ area (built-up carpet) at STPI-Guwahati CoE approximately is 1592.49 Sq. ft. (1286.99 Sq.ft as outside terrace space and 305.50 sq.ft. as SIZ display area) available on 1st floor of STPI-Guwahati office building. In addition to this, STPI-Guwahati also has open space at back yard of the office building which may also be used for establishment of the SIZ.



The following are the broad scope of work for the agency:

- Design the process layout for the SIZ area in OctaNE CoE in "IoT in Agriculture" at STPI-Guwahati. The proposed process layout must be in line with the objectives of the SIZ and should be able to support different demonstrable use cases in the focus area of the CoE.
- Prepare and submit a detail BOQ for the SIZ covering all equipment and components proposed
- Supply and install all the equipment and components in the CoE SIZ area
- Impart necessary training on all supplied equipment for operating and maintaining the SIZ area
- Selected agency is required to provide 3-year comprehensive support for capital goods including applicable warranty period. Standard warranty will be applicable for all other components.

- iii. Any request for clarification after the indicated date and time may not be entertained by STPI.
- iv. The STPI will endeavour to provide timely responses to all queries. However, STPI makes no representation or warranty as to the completeness or accuracy of any response made in good faith, nor does STPI undertake to answer all the queries that have been posted by the agencies.
- v. STPI is not bound to clarify any query received after the date as described above. STPI will review every query and on due consideration will issue a corrigendum, if so required. However, STPI does not undertake to answer each query(ies). Agencies shall not assume that their unanswered queries have been accepted by STPI.
- vi. The corrigendum (if any)/ clarification to the queries from agencies will be posted on the procurement portal https://eprocure.gov.in/. Any such corrigendum shall be deemed to be incorporated in this EoI.
- vii. To provide prospective agencies reasonable time for taking the corrigendum into account, STPI may, at its discretion, extend the last date for the receipt of the EoIs.

8.3 Completeness of the Eol Response

Agencies are advised to study all instructions, forms, terms, requirements, and other information in the EoI documents carefully. Submission of EoI shall be deemed to have been done after careful study and examination of the EoI document with a full understanding of its implications. The response to this EoI should be complete in all respects. Failure to furnish all information required by the EoI documents or submission of a proposal not substantially responsive to the EoI documents in every respect will be at the agency's risk and may result in the rejection of their proposal.

8.4 Proposal Preparation Cost

The agency is responsible for all costs incurred in connection with participation in this process, including, but not limited to, costs incurred in the conduct of informative and other diligence activities, participation in meetings/discussions/presentations, preparation of the proposal, in providing any additional information required by STPI to facilitate the evaluation process. STPI will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the EoI process. All materials submitted by the agency shall become the property of the STPI and may be returned at its sole discretion.

8.5 Amendment of Eol Document

At any time before the deadline for submission of EoIs, the STPI, may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective agency, modify the EoI document by an amendment. All the amendments made in the document would be informed to all the participating agencies through mail or written post. The agencies are advised to visit the website



(https://eprocure.gov.in/) on regular basis for checking necessary updates. STPI also reserves the right to amend the dates mentioned in this EoI for the EoI process. In order to afford prospective agencies reasonable time in which to take the amendment into account in preparing their EoIs, the STPI may, at its discretion, extend the last date for the receipt of EoIs.

8.6 Selection Criteria for the next level

STPI will consider the agencies, that have technically qualified, for the next round of RFP. The agencies selected through this EoI process shall have 1 year validity period which may be extended in case required. RFP will be floated for the selected eligible agencies under this EOI.

8.7 Evaluation Process

The agency must possess the technical know-how and the financial capabilities that would be required to successfully provide the services sought by STPI. The agency's proposal must be complete in all respects and conform to all the requirements, terms and conditions and specifications as stipulated in the EoI document. The evaluation process of the EoI proposed to be adopted by STPI is indicated under this clause.

STPI shall appoint an EoI Evaluation Committee (EEC) to scrutinize and evaluate proposals received. The EEC will examine the proposals to determine whether they are complete, in response and whether the proposal format conforms to the EoI requirements. STPI may waive any informality or nonconformity in an EoI that does not constitute a material deviation.

8.8 Notifications of consideration for the next level

Prior to the expiration of the period of proposal validity as defined in the factsheet provided at Of this RFP, the agency will be notified in writing or by fax or email that it has been considered for the next round i.e., RFP (if published).

8.9 Rights to terminate the Process

STPI may terminate the EoI process at any time and without assigning any reason. STPI makes no commitments, express or implied, that this process will result in a business transaction with anyone. This EoI does not constitute an offer by STPI.

8.10 Language of Eol

The responses prepared by the agency and all correspondence and documents relating to the Eol exchanged by the agency and STPI, shall be written in the English language, provided that any printed literature furnished by the agency in another language shall be accompanied by an English translation in which case, for purposes of interpretation of the Eol, the English translation shall



govern. If any supporting documents submitted are in any language other than English, translation of the same in the English language is to be duly attested by the agency.

8.11 Rights to Accept/Reject any or all Proposals

STPI reserves the right to accept or reject any proposal and to annul the EoI process and reject all EoIs at any time prior to award of contract, without thereby incurring any liability to the affected agency or agencies or any obligation to inform the affected agency or agencies of the grounds for STPI's action.

8.12 Failure to agree with the Terms & Conditions of the Eol

Failure of the agency to agree with the Terms & Conditions of the EoI shall constitute sufficient grounds for the annulment of selection.

8.13 Indemnity

The successful agency shall indemnify, protect, and save STPI against all claims, losses, costs, damages, expenses, action suits and other proceedings, resulting from infringement of any patent, trademarks, copyrights etc. or such other statutory infringements in respect to services rendered by agency.

8.14 Conflict of Interest

- i. A Conflict of Interest is where a person who is involved in the procurement has or may be perceived to have a personal interest in ensuring that a particular Agency is successful. Actual and potential conflicts of interest must be declared by a person involved in the EoI process.
- ii. Where there is any indication that a conflict of interest exists or may arise, it shall be the responsibility of the Agency to inform STPI, detailing the conflict in writing as an attachment to this EoI.
- iii. STPI will be the final arbiter in cases of potential conflicts of interest. Failure to notify STPI of any potential conflict of interest will invalidate any verbal or written agreement.

8.15 Eol Proposal Submission Format

The entire proposal shall be strictly as per the format specified in this Expression of Interest. EoIs with deviation from this format shall be liable for rejection.

9 General Terms and Conditions

- ii. Willful misrepresentation of any fact within the EoI will lead to the disqualification of the Agency without prejudice to other actions that STPI may take. All the submissions, including any accompanying documents, will become the property of STPI. The Agencies shall be deemed to license and grant all rights to STPI, to reproduce the whole or something any portion of their proposal document for the purpose of evaluation and to disclose the contents of submission for regulatory and legal requirements.
- iii. Agencies must inform STPI immediately in writing of any material change to the information contained in the EoI application, including any substantial change in their ownership or their financial or technical capacity. Copies of relevant documents must be submitted with their information. For shortlisted Agencies, this requirement applies until a contract is awarded as a result of the subsequent bidding process.
- iv. A brief overview of the proposed procurement/scope of work given in this document may be further elaborated, viz., more details may be included in the Request for Proposals (RFPs) to be issued as a result of the evaluation process of this EoI.



- v. STPI reserves the right to formulate any terms & conditions while framing the RFPs, even if these are in variance with the terms provided in this EoI. Further, the Agencies shall have no claim in this regard.
